### **December 14<sup>th</sup>, 2022**

**Council Members Present:** All council members were present as well as Pastor Barry.

Joe called the meeting to order and Pastor Barry opened it with prayer and a message on how the song "Oh little town of Bethlehem" came to be. He also put together a chart on our membership by age groups. It was surprising that there are only 12 members between the ages of 18 and 30. He asked for the council's permission to talk to a few of those members to see if they would be interested in heading up a young adult's ministry at our church. Council approved.

The secretary's minutes were approved from the November 9<sup>th</sup> meeting.

Karen gave the treasurer's report. The beginning balance was \$494,330.42 with an ending balance of \$505,137.54

#### **January 11<sup>th</sup>, 2023**

**Council Members Present:** All council members were present as well as Pastor Barry.

He met a woman who is 75 that he bought a bible for and she has come to know Christ and reads it for him. Story being that God's word can be shared in so many ways...young and old can bring Christ into one's life! Pastor Barry visited with a couple of younger adults regarding a young adult ministry. They are giving it some thought. He also knows of a couple that may be interested in helping with this ministry and with the council's approval will talk to them as well.

The secretary's minutes were approved from the December 14<sup>th</sup> meeting.

Karen gave the treasurer's report. The beginning balance was \$505,137.54. After most of the designated funds were paid out in December, the ending balance was \$502,124.13

- A request was made to change a line in the Communion and Altar Preparation Duty List in the policy book. M/S/C to make this change. Pam will update as requested.
- Leslie Smith asked if she could create a Facebook page for Sunday School that would be private and only allow for parents of SS kids or church members to join. This would allow for those that miss a Sunday be able to catch up the lessons and on things such as words for the songs that they sing. Council approved.

## Annual Meeting Minutes January 22, 2023

President Joe Blackbird called the meeting to order. 42 members were in attendance. Pastor Barry Marchant opened the meeting with prayer.

Clipboards were passed around for those in attendance to sign-up for ushering / custodial / communion duties. Joe thanked Pastor Barry for pastoring St. John's Church through our transition.

- Pam Martin read the minutes from the 2022 Annual Meeting. The minutes were approved as presented.
- Review of the Annual Reports were given as follows:
  - **General Fund, Memorial Fund, Choir Fund, and Congregational Direct Giving were given** by Karen Konerza. A question was asked regarding where the \$400.00 for missions will go. Karen said that is being discussed by the council as there have been offerings designated for missions on the offering envelopes.
  - **Membership & Attendance Record** by Karen Konerza
  - **Benevolence** by Karen Konerza
  - **Building Fund** by Brian Alsleben. A question was asked about a refund from Guide One. Brian explained that we switched insurance providers because of a substantial savings and we already had paid the premium to Guide One (cancelled insurance). This was the refund.
  - **Women's Guild** by Brenda Schaefer
  - **Youth Group** by Andrea Wigern
  - **Sunday School** by Andrea Wigern
  - **Financial Review** report was given by Pam Martin. She stated that the review committee found the financial records for 2022 were accurate and in good order.

Motion/Second/Carried to approve all reports as presented.

### **New Business:**

- Joe Blackbird presented the **Operating Budget** report. Mary Huebert donated her organist services again this year. (Thanks Mary!). The Secretary's salary and Organist's salary would stay the same. Some of the categories were increased slightly while some were decreased. The total budget is \$78,300. In order to meet the budget, on average, each family unit will need to contribute about \$2,610 total for the year. This equates to about \$50 for 52 weeks. M/S/C to accept the budget.
- Joe Blackbird reviewed the proposed 2023 service times and dates. Dates and times are all equivalent to last year except Easter Service will again be at 9:30am. Some of the dates/years were corrected to reflect actual dates. Congregation approved.
- Joe Blackbird informed the congregation that the council received a suggestion regarding putting in handicap door openers. One of the quotes came in around \$7,000 which would include both doors and electrical services. The council will get two other bids and will keep the congregation updated along with getting congregational approval in the near future.
- David Swift gave an update on the progress of the endowment policy committee which includes: Brian Alsleben, Joe Blackbird, David Swift and Bob Taylor. This committee has met about 24 times so far! They have done a lot of research and have gathered example policies from other endowment funds. The committee has a near-final draft of the policy and are ready to survey potential local investment managers who will help manage the assets in the fund, including James Peters. When a final draft is complete, they will send out information packets to all members for their review. A congregational meeting will be held sometime in April to vote for adoption of the policy, vote for members of the first endowment committee, and vote for the recommended investment manager. A big thank you to the committee for all the work and time you have put in!
- Volunteers/Staff Elections
  - **Council:** Karen Konerza and Cory Garoutte have completed their second term on the council. Pam Martin has completed her first term and volunteered to be on the council another year. Dawn Norrbom and Barb Buckentin volunteered to be on the council. M/S/C to elect Dawn and Barb to the council for their first terms.

- **Search Committee:** Celine Swift, Julie Karl, Doug Block, and Gene Konerza volunteered along with one representative from the council to be determined.
- **Ice Cream Social Committee** – June 8<sup>th</sup>, 2023. Barry Marchant and Marcie Baysinger volunteered and will contact other members to see if they are interested.
- **Financial Review Committee** – Pam Martin, Brenda Garoutte, and Brian Alsleben will be on the committee again.
- **Benevolence Committee** – Elaine Carrigan and Mavis Mielke
- **Nursery Committee** – Michelle Alsleben, Ashley Alsleben, Jessica Alsleben and Zachary Zeleke.
- **Records Keeper** – Karen Konerza
- M/S/C to accept the above committee volunteers. Motion carried.

Lea Ette Peters wanted to give Mary Huebert a shout out for all the work she does for our Church. Congregation agreed with applause!!

A motion was made and seconded to adjourn the meeting. Motion carried.

## **St. John's Cemetery Association Annual Meeting Minutes** **January 22, 2023**

The annual meeting of St. John's Cemetery Association was called to order by David Swift following the church's annual meeting.

Minutes from the 2022 annual meeting were read by David Swift.

A motion to accept the minutes as read was made by Joe Blackbird. It was seconded by Pam Martin.

The motion passed with voice vote.

Concern was raised by Mark Wigern over the cost of lawn mowing. Everyone agrees that the lawn looks nice, but Mark was surprised that with the lack of rain that there was a need for so many mows last season. David clarified that St John's paid \$298 per mowing and there were 20 mows. The cemetery association will look into the frequency of mowing depending on the need.

New Business:

1. Funding Shortfall. Currently the income donations to the cemetery fund are less than the expenses. David asked the congregation to please consider giving to the cemetery fund in your donations.
2. There was one burial in 2022: Gary Frahm.
3. CD's. Last year the decision was made to cash out CD's when they mature and find a different, more profitable investment. Typically, the interest we gained has been around \$300 per year. With Vanguard we estimate we could see a gain of around \$2,500 a year.
4. Flowers and stands. Reminder that all flowers and stands must be removed before Labor Day to prevent a mess in the Fall and Spring as they deteriorate.
5. We have not yet received a quote from Allan Raduenz for 2023 mowing.
6. Warren Kaufmann has completed his term and is no longer eligible for another term. Warren nominated Dave Sanken as his replacement. Dave was not present, but had agreed to serve prior to the meeting. Richard Swift second the motion. All in favor. Dave Sanken was accepted as Warrens replacement.

A motion was made and accepted to adjourn.
